Open Elective (OE) (Any ONE)
1. Direct Taxation (Sem V) and Indirect Taxation (Sem VI) (4 Divisions) OR 2. Fundamental and Technical Analysis (Sem V) and Equity and Debt Markets (Sem VI). (2 Divisions)

Note: Allocation of Optional subjects will be based on merit and the availability of seats. Subjects once allotted cannot be changed. Those Students who have not filled the Google Subject Preference form will be allotted only Fundamental and Technical Analysis (Sem V) and Equity and Debt Markets (Sem VI).
