Communication with Students and Parents:

The College shall send important notices and updates to the email address provided in the admission form. Students and parents should regularly check their email and the College website for updates.

Documents / Identity Card

Every student of the college must possess with him/her the Identity Card given by the college. It is mandatory for students to wear I-cards in the college premises. Students without Identity Cards will not be allowed to enter the college premises.

In the event of loss of Identity Card, the students concerned must file a complaint at the police station and report to the college with "a copy of the complaint, in writing. The college may issue a duplicate identity Card if the student gives a satisfactory explanation for the loss of the Identity Card.

The Identity Card must be produced whenever demanded by a member of the college staff, including the security at the main gate. The security is empowered to deny permission to a student from entry to the college in the absence of his/her Identity Card.

Railway Concession:

All students are eligible for concession on railways for local journeys between the station nearest to their place of residence in Mumbai and the college. As per the railway rules students cannot avail local concessions after the annual examination when lectures or assignments are not in progress.

Long journey railway concessions will be granted during vacation only for journeys between their places of permanent address as per the rules published by the railways.

Railway Concession can be availed at the college office counters on working days:
12noon to 1pm / 2.45pm to 3.45 pm .



Scholarships and Freeships

All scholarships and freeships are awarded only to students with good conduct, who have performed well in examinations, tutorials and tests.

Students with poor attendance in the college are not eligible for obtaining scholarships and freeships. Freeships, are not awarded to students, who get college merit scholarships or aid, from any other institution or the government.

Government Scholarships and Freeships.

The scheme of grant of Government of India scholarships to backward class students as Specified by the State Government, applies to students and others coming under the lower income group. Such students have to apply for the Government of India Scholarships in the prescribed form through the college office only in the month of June. Students should collect the application form at the proper time from the college office, fill in and submit the same duly completed to the college office before/on the stipulated date. Incomplete, incorrect or false information furnished in the application will render the applicant disqualified for scholarships. Students having a gap in the course of Education should file a court affidavit declaring that what they were doing during the break in their career. Students in receipt of government of India scholarship in the preceding year and having passed University HSE or annual examinations are required to submit an application for the renewal of the set scholarships



Applications for freeships / Scholarships are generally rejected on the following grounds :

- The income of the student's father / guardian exceeding the prescribed limit.
- The student being a repeater, or
- The student having switched over from a professional course, or being in employment.
- In addition to the scholarships and freeships mentioned above, the following Union and State Government Scholarships and Freeships are available to eligible students.

A. Scholarships

- National Loan Scholarship.
- Maharashtra State Government Open Merit Scholarship.
- Scholarship for Children of Political Sufferers and Freedom Fighters.
- Merit Scholarships for children of Primary and Secondary School Teachers

B. Freeships are given to:

(i) All girl students certified to be eligible by the Department of Education, Maharashtra State.

(ii) Children of parents whose annual income is below Rs. 2.5lakh/-per annum.

iii) Children of full- time primary school teachers backward class students who have been given Government of India Scholarships .Schedule Castes, Schedule Tribes and other backward and economically backward class students who have been granted scholarships free ships are required to maintain good progress and keep not less than 75% determinants during each of the terms in order to qualify for the award continuation of scholarships or free scholarships. State scheduled government Rajeev Gandhi students accidental Insurance Policy:



- Rs. 30,000 for unfortunate accidental death.
- Rs. 50,000 for permanently handicapped.
- Rs. 20,000 for Impairment of any limb or an eye
- Rs. 2,000 for medical treatment.
- Maximum Rs. 10,000 for surgery.
- Rs. 350 for book loss in an accident.
- Rs. 650 for the students who could not appear for the exam (because of an accident) as examination fees.
- Rs. 1500 in case of damage or theft of a bicycle.
- Schools, Higher & Technical, Tribal, Agricultural, Social Justice, Cultural Work, Medical related and approved school and Colleges are eligible for it.

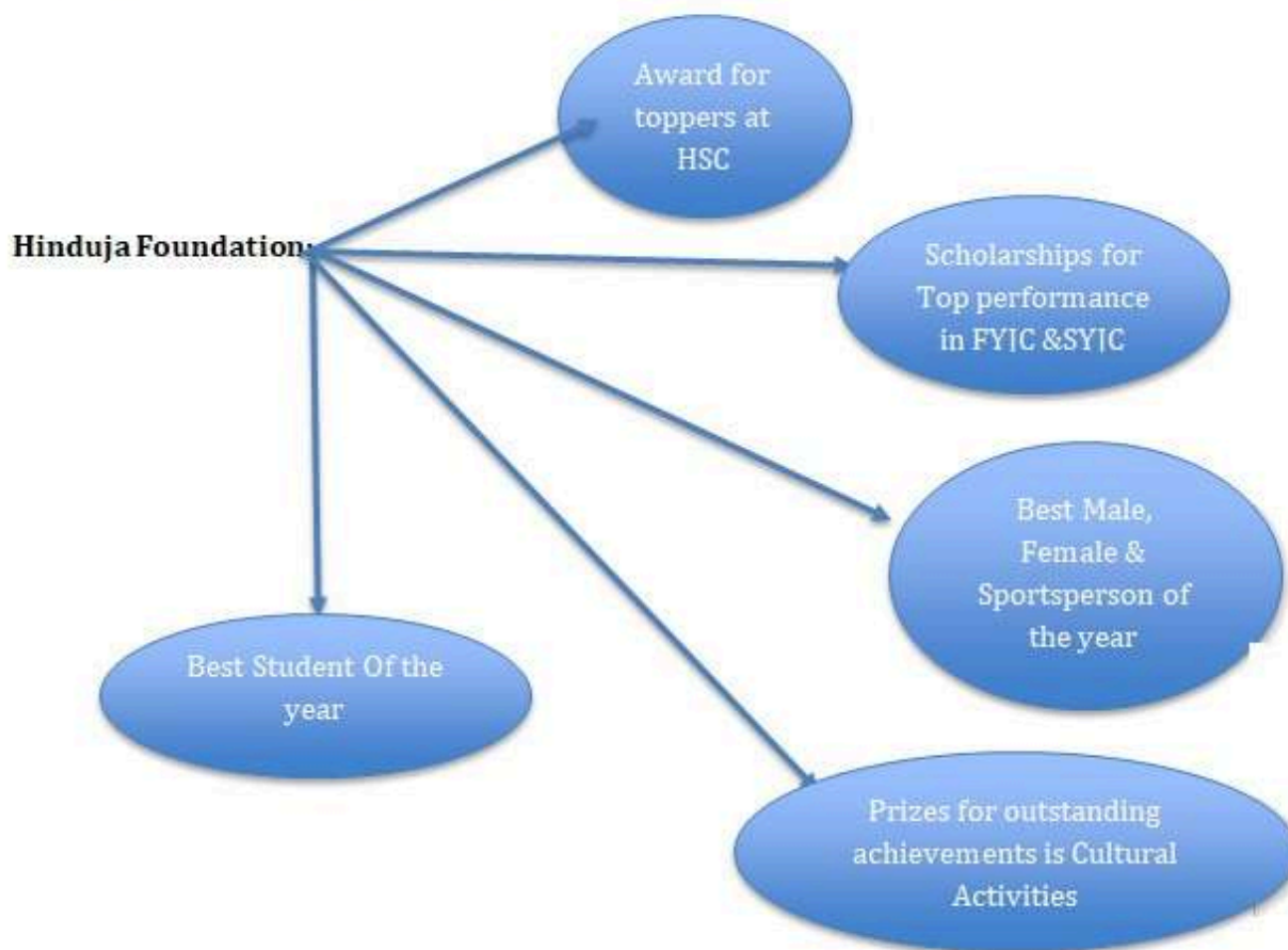
Hinduja Foundation Scholarships

- Students are eligible for Hinduja Foundation Awards provided they continue their studies in this college.
- Details of various free ships and scholarships instituted by the government will be displayed on the college notice board or may be displayed on the college website..

Infrastructure and Facilities.

LIBRARY

The college has an up- to -date library with many standard books of reference, periodicals, newspapers, journals, e-books, e-journals and online and offline resources. Students shall be allowed in the library only on production of a valid identity card and shall be issued books against the readers ticket provided by the library. Failure to return the book issued for home reading within the time limit will invite a levy of fine. If the readers ticket is lost the student concerned must inform the librarian immediately in writing and apply for a new readers ticket. Reference books, examination question papers, daily newspapers and certain textbooks cannot be taken out of the library. Books and periodicals must be returned on the same day before the library closes for the day. Failure to do so will render the student liable to pay fine.



Students must be careful in handling Library books, periodicals and journals. Smoking or spitting in the library hall or in any part of the college is strictly prohibited. All students are required to maintain silence in the library. Ex- Students are not entitled to the library or reading room facility. Students are requested to refer to the library notice board for instructions that may be issued from time to time.

DISCIPLINE

- Every student must possess a valid Identity Card issued to him/her by the college with his/ her photograph ethics and it must bear the signature of the principal. She/he is under obligation to present it for inspection or verification or for any other authorized purpose whenever demanded by the member of the college staff. Attendance at lectures tutorials and tests if any, according to the timetable in force is compulsory. When a student cannot attend lectures, they must admit a note signed by his /her parents or lawful guardian to the principal stating reasons for their inability to attend. Students failing to submit such a leave note within a reasonable time will be liable for disciplinary action.
- No student can attend any class other than his/her own except with the prior permission of the teacher concerned,
- Every student must take proper care of the college property and help in keeping the college premises clean and peaceful.

Disciplinary action will be taken against students who :

- Misuse, disfigure, damage wall, windows furniture and the fittings of the college.
- Loiter about in the college while the lectures are in progress.
- Organize any activity program or drive, without prior permission of the Principal.
- Convey any misinformation about the college to anyone or write to the press to bring the college to disrepute without proper justification.
- Students found guilty of disobedience, misconduct or misbehavior or any other act of serious indiscipline are liable to either lose their terms or be expelled from college.
- Mobile phones are banned in classrooms during lectures. Defaulters will be penalized.
- Students should note that only members of the teaching staff are entitled to confiscate the mobile phones.
- Students involved in cases of physical assault and use of verbal abuse will be suspended from the college within immediate effect.
- Students who are involved in copying cases bracket caught with written material, will be given zero marks in the set subject and will be denied admission to SYJC even if they manage to pass SYJC with good percentage.



Anti-Ragging

The college has a zero- tolerance policy towards ragging. The college confirms with all the guidelines on Anti-Ragging issued from time to time.

Sakhi Savitri Committee:

The Sakhi Savitri Committee is a safety and empowerment group established by the Maharashtra Education Department to create a secure, supportive environment for students, particularly girls. The committee's focus is establishing safe and secure environment in the institution by conducting awareness programs, counseling and addressing grievances.

ATTENDANCE

Every student joining this college must attend, at least 75% of the total Number of working days in each term of the academic year. Unsatisfactory attendance without sufficient ground may result in the cancelation of admission of the concerned student.

A student who for whatsoever reason is unable to attend the college for more than 25% of the total number of working days of any given month from the commencement of the academic year is liable for disciplinary action.

A list of defaults in attendance is put up on the 10th of each month on the notice board of the college similarly such a list will be put up at the end of each term students are advised to see the notice board/College website regularly.

A student who is a regular participant in extra -curricular activities and sports is required to have a minimum of 50% attendance in each term separately as per board rules. Special consideration will be given in such cases where it becomes necessary for a student to remain absent from the class for attending or participating in any game sports or extra- curricular activities organized by the college at the state level provided such a student produces the requisite certificates from the chat person of the concerned association organization.



Regulation 88 (1) Of the Maharashtra Secondary and higher secondary education board regulation, 1977, clearly states that a candidate should attend lectures for not less than 75% of the working days separately in two different terms may not be allowed to appear in the final examination unless he/she completes the minimum attendance prescribed under this clause

SYJC students who figure continuously in the defaulter list below 50% during the first term may not be permitted to appear for the terminal examination held by the college. FYJC students who constantly figure in the zero percent attendance list will be denied admission to the SYJC. To encourage students to be regular and disciplined cash awards may be given to students with 100% Attendance as decided by the Principal and the management from time to time..

SUBJECTS OF STUDY

At the Junior College level a student has to study English, Economics, Book-Keeping and Accountancy, Organization of Commerce, EVS,PT and one of the following :

- Mathematics and Statistics
- Secretarial Practice and a modern Indian language; i.e. Marathi, Hindi, or Information Technology.
- The above mentioned optional languages, optional subjects and timings are subject to change as per requirements from time to time.
- To pass in a subject, the minimum requirement is 35 marks out of 100.
- Higher Secondary Certificate will be awarded in grades as given below.

Grade1: (With Distinction): To successful candidate who obtain 75% and more marks in the aggregate, calculated on the basis of 6 subjects offered for the examination.

Grade 2 : To successful candidates who obtain less than 75% but not less than 60% marks in the aggregate calculated on basis of subjects offered for the examination.

Grade 3: To successful candidates who obtain less than 60% marks but not less than 45% marks in the aggregate calculated on the basis of 7 subjects offered for the examination.

Grade Pass to all other successful candidates.

The marks of EVS and PT will be converted into a grade and will be shown in the Annual Result. It is mandatory to pass in EVS and PT to be declared 'pass' in 11th and 12th Examination.



EXAMINATION SCHEME FOR LANGUAGES:

Every Language (English / Marathi / Hindi) for FYJC & SYJC. is prescribed for 100 marks consisting of written examination of 80 marks of 3 hours duration and an Oral examination of 20 marks. Written examination for S.Y.J.C. will be conducted by the H.S.C. Board and the Oral examination will be conducted by the College and the marks will be submitted to the H.S.C. Board, For FYJC students, the Oral Examinations of 20 marks will be held only once (before the Annual written paper). These examinations tests the student's listening and speaking skills. If the student remains absent for the same, his/her result will not be declared till the student appears for re-tests. Such students will get admission to SYJC only in the month of June.

- Attendance at the Examinations is compulsory. If a student fails to appear for these Examinations, he/she will not be granted Terms.
- After the completion of each Examination, results will be declared within two / three weeks. Assessed answer books of each subject will be shown to the student in the classroom by the subject teacher or may be displayed on the college website.

- Parents should note that the student will be examined for 200 marks (Maximum) in each subject. The final result will be decided on the basis of the average marks obtained at these examinations which is calculated using the formula,

- Minimum marks for passing in the subject is 35 and a student will be required to pass all subjects for promotion to SYJC class. A total of 15 grace marks not more than 10 in any subject and only in three subjects will be awarded to the students only if they secure 25% marks in the average
- There is a separate rule for grazing for students with learning disabilities. This rule is applicable only if the student has submitted the LD certificate to the exam committee at the time of admission.
- Re- examination for terminal annual examination for medical cases will be conducted in the college as a rule there is no re- examination for Unit Test.

There shall be no re-examination in the case of students who have failed.
